

Course Description:

Since 1997, the APTA has encouraged all Clinical Instructors to take this course, to help standardize entry level clinical education. PT and PTA clinical instructors interested in enhancing their clinical teaching abilities will participate in an instructional session followed by a self-assessment laboratory experience that culminates in the participant receiving credentialing as a clinical instructor. Other healthcare professionals may take the course, but are not permitted to complete the Credentialing (Assessment Center) Component of the program. The course is limited to 20 participants.

Course Objectives:

- Plan and prepare for students during their clinical education experiences
- Develop learning experiences in practice tailored to meet specific student needs
- Support ongoing learning through questions and effective feedback
- Identify and manage students with difficulty and/or exceptional situations
- Identify legal, legislative, and regulatory implications for clinical educators, including issues presented by ADA, HIPAA, and Medicare.
